## CONSENT WAIVER

**Cell Phone Policy** Camp Waianae is a place for campers to separate themselves from the outside world as much as possible and enjoy time with friends, their counselor, and God—there is no need for technology. Additionally, we want to preserve the safety of your camper(s) at all times while at Camp Waianae, and cell phone usage can complicate and/or hinder this. Therefore, due to our safety rules and regulations, there will be a designated cell phone usage time following lunch, during which campers may use their phones. Outside of this time period, campers' cell phones and electronic devices will be kept in a safe and secure location by their Village Director.

In case of extreme emergencies, you may contact our main office and we will get you in contact with your camper(s), but please reserve this for emergencies only, as we do not have the capacity for many campers to receive calls. We must keep our phone lines open throughout the week, therefore if there is ever anything involving your camper(s) that you must know about, then we will contact you immediately. If you do not hear from us, then that means that your camper is safe and having a great time!

**Camp Store Policy** The Camp Waianae store sells shirts and water bottles, as well as other souvenirs and a variety of snacks and beverages. If you establish a camp store account, please make sure that the amount in the account is suitable for your child. All funds that have not been used by the end of your child's week of camp will be donated to the camp to help keep camp available at a reasonably low rate. Please explain this to your child. We provide many opportunities throughout the week for campers to visit the store and make purchases. The camp store will also be open during registration and camper pick up.

**Zero Tolerance Policy** Camp Waianae is a place where we embrace youth and work with everyone in various and unique situations. Being at camp is a privilege, and although we make every effort to maintain that privilege's ability, there are certain things that are unacceptable. Unfortunately, in the case of one of the following situations, arrangements may be made to send your camper(s) home, at your expense: Leaving the Campgrounds Without Permission, Violent Behavior, Drug, Tobacco, or Alcohol Possession/Use, Tampering with, Stealing, or Destroying Camp or Campers' Property.

**Activity Release Waiver** Camp Waianae has done everything reasonable to assure that our camp programs (including challenge course, paintball, and ocean activities) have been made as safe as possible. However, we wish to inform you that camp activities are not without risk. As in any camp activity, such as those previously stated, inherent risks exist and may result in serious injury or death. Your camper should only participate after you have read the description of all the activities listed on our website and/or other camp materials. Please note, should you not want your camper to participate in any of these specific programs, please list them in writing on a separate sheet of paper and attach it to the application. Phone calls are not acceptable for exclusion.

**Emergency Release** In case of emergency, I hereby give permission to the physician(s) selected by the camp directors to hospitalize; secure proper treatment for, and to order injection, anesthesia, or surgery for my child. As parent or legal guardian of the applicant, I am in favor of him/her attending camp, and accept the conditions named. The health history and application information are correct, as far as I know, and the person herein described has permission to engage in all prescribed camp activities, except as noted.

By signing below, I acknowledge I have read the above statements and consent to their conditions. I realize camp activities have inherent risks. I knowingly accept and assume this risk, and agree to release Camp Waianae, its employees, the Hawaii Conference of SDA, and its parent organizations from liability in case of accident or illness. Camp Waianae is not responsible for lost or damaged personal items, including cameras, phones, and personal recreational equipment, etc. I also agree that photographs and video of the applicant may be used for camp promotional materials. I agree to abide by all camp regulations and policies and to uphold its objectives. I will reimburse Camp Waianae for any expenses to cover damages or charges due to infractions

IMPORTANT: If you are registering campers who are not your children or under your direct care, it is your responsibility to communicate these guidelines to their parent(s) and/or legal guardian. By signing this document, you are stating that you are aware of our policies, as outlined above.
